The 66th meeting of the Physiotherapy Board of Australia (the Board) was held on 25 September 2015 at the National Office of the Australian Health Practitioner Regulation Agency (AHPRA) office in Melbourne.

Online renewal of registration is now open

Online renewal of registration is now open for physiotherapists registered in Australia.

Physiotherapists who are due to renew their registration with the Physiotherapy Board of Australia (the Board) by 30 November can apply online now.

Physiotherapists are reminded to carefully read the Board's <u>registration standards</u> which specify the profession's standards of practice before making the required declarations in their application for renewal of registration.

Earlier this month the Board announced that it had lowered its fees for the registration period from 1 December 2015 to 30 November 2016. A <u>fee schedule</u>, including the fee arrangements for practitioners whose principal place of practice is NSW¹, is published on the Board's website.

The National Registration and Accreditation Scheme (the National Scheme) is funded by practitioners' registration fees and there is no cross subsidisation between professions.

A series of reminders to renew are being sent to physiotherapists by the Australian Health Practitioner Regulation Agency (AHPRA), on behalf of the Board. The email reminders include a link to <u>online renewal</u> so it is hoped that physiotherapists acted on an earlier call to update their contact details.

Expressions of interest to join the Registration and Notifications Committee

The Board will refresh the membership of its Registration and Notifications Committee (RNC). The RNC has duties delegated to it by the National Board which include the consideration of notifications (complaints) made about physiotherapists. An Expression of Interest process will be advertised on the Board's website in the coming weeks.
